1/3 Mile Kids' Run (10 and Under) Information: 1/3 Mile Kids' Run will start and finish in front of Two Rivers High School at official Two Rivers 10-Mile starting line. Participants will proceed North 1/6 mile, go around a sign, and return 1/6 mile back to start/finish. Entire run will be on TRHS campus on a road closed to traffic. Participants will receive a cotton shirt, race bib, awarded a ribbon after finishing, and milk and cookies will be served in TRHS cafetorium after run. Top 3 overall boys and girls will be awarded medals. Parents/guardians are encouraged to accompany children 5 and under. In case of inclement weather, 1/3 Mile Kids' Run will take place in TRHS Gymnasium.
